# STUDENT SERVICES - DRUG & ALCOHOL PREVENTION WORKER

Location: Schools

### SUMMARY:

Reporting to the Principal/designate, the Drug & Alcohol Prevention Worker provides prevention services in the area of addictions, provides early intervention and referral, takes a leadership role in mobilization functions including but not limited to networking, consultation, promotion of prevention materials, providing training and information sessions and uses a variety of developmental techniques to develop youth-based prevention programs.

### **DUTIES**:

- Utilizing a variety of approved models plans and implements health promotion and substance misuse prevention activities
- Provides information to youth and parents on community resources and recommends appropriate services as required
- Educates school personnel on health promotion and substance misuse prevention by participating in meetings, conducting in-service sessions and providing educational resources and promotional materials
- Assists in the planning of and participates in substance misuse awareness initiatives such as Drug Awareness Week and Counter Attack Clubs
- Works collaboratively and inclusively with the students being served when planning, implementing and evaluating prevention activities
- Develops culturally appropriate programs and activities
- Establishes and maintains policies and procedures
- Maintains a liaison with relevant Ministries, agencies and professionals (school and community based) providing resource consultation as required
- Maintains related records and provides reports to the supervisor as required
- Communicates effectively using courtesy, tact and discretion with school staff, students and parents in the explanation and clarification of information
- Maintains the confidentiality, appropriate boundaries and other basic counseling ethics
- May be required to perform other assigned comparable duties which are within the scope of knowledge, skills and abilities required by this

- Two years of experience in the provision of drug & alcohol counseling
